

# DECORATE YOUR OWN SNOWFLAKE

## Terms & conditions

- a) To enter into this prize competition (the 'Competition') entrants must decorate the Christmas Snowflake (the 'Design Entry') and submit their entry by either:
  - using the aubergine post box located in between Phase Eight and Yi Fang on The Avenue;
  - by post: The Lexicon Annual Art Competition 2022, The Lexicon, Management Suite, Lower Ground, The Avenue Car Park, Bracknell, RG12 1AP;

- b) Entry into this Competition constitutes acceptance of these terms and conditions.
- c) Only one Design Entry per person from the choice of the four snowflake templates.
- d) No purchase necessary.
- e) All entrants must be aged between 3 - 12 years, have obtained parental / guardian consent and have a UK postal address. Employees of The Lexicon ('The Lexicon'), their families, dependants and agents and any other person connected with the Competition may not enter.
- f) All Design Entries must be received between 21 October 2022 and 13 November 2022 inclusive. The Lexicon cannot accept any liability for any Design Entries which are late, lost or incomplete.
- g) The Lexicon reserves the right to refuse to accept any Design Entry and / or to select a winning Design Entry at The Lexicon's absolute discretion.
- h) Failure to comply with these terms and conditions will automatically render a Design Entry void. These terms and conditions shall be governed and construed in accordance with English law.
