

## **Terms & conditions**

Please read these promotion rules carefully. By entering a promotion, you are deemed to accept and be bound by these terms and conditions.

- 1. To enter a promotion, you must be: (a) from Berkshire and neighbouring counties; (b) aged 18 years or over at the time of entry and (c) complete the short survey on the reverse of the entry forms.
- 2. Every completed Gnasher trail entry form will receive a FREE Beano Comic (while stocks last) which will be available from Craft Coop (opposite Specsavers) in Princess Square from Saturday 10 to Sunday 18 February 2024 from 10am to 5pm Monday to Saturday and 10am to 4pm on Sundays
